Consent to Establish (CFE)	Identity proof of the applicant (EPIC / Aadhaar / Driving License / PAN Card / Passport),
	2. Proof of Ownership / Legal occupancy (Rent agreement, Rent receipt, Parcha, Land deed, Lease documents etc. as applicable).
Consent to Operate (CFO) (Fresh)	Item 1 & 2 as required for CFE and 3. Copy of CFE certificate along with compliance status
Consent to Operate (CFO) (Renewal)	Item 1 & 2 as required for CFE and Fresh CFO and 3. Status of compliance of previous directions / conditions (if any).
